AGM 2020

The Club's AGM 2020 was finally held at the Sapura Dining Deck on Saturday, 25th August 2020. The AGM, originally scheduled to be held on Saturday, 25th April, 2020, had to be postponed due to the imposition of the MCO from 8th March, 2020.

This year saw a high attendance of 96 members registered for the AGM. The meeting began at 4.10 pm. Some agenda topics like the conditions of the Club's pontoons, sailing yachts and the two motions for rule changes were the focus of much of the discussions and debate. After a half an hour break at about 6.30 pm to await final compilation of the ballots, the election results were announced by the Hon. Secretary at 7.10 pm. This concluded business for the day and the Chairman closed the meeting at 7.20 pm.

At the AGM2020, the following motions were tabled and decided by the Members, viz:

Motion for Rule Change: (1) Term Membership:

VOTES FOR : 37 VOTES AGAINST : 15

The motion to introduce a new class of membership, viz. "Term Membership" with a fee of RM1,500 for an annual term, was carried.

Motion for Rule Change: (2) Slot Machines:

VOTES FOR : 45 VOTES AGAINST : 1

The motion to amend the "Objectives" by adding in "slot machines" as an activity offered by the Club to its Members, was carried.

Any Other Matters: (1) State of the Pontoons:

The motion was carried, unanimously. A Sub-Committee to carry out an evaluation and to make recommendations will be formed with volunteers from the floor, viz: Mr. Ian Pereira, Mr. Edward Chin, Mr. Jeremy Camps, Capt. Stanley Yeong, Mr. Jeff Harris and Mr. Anthony Sobey. Representative(s) from the Committee to be appointed later.

Any Other Matters: (2) To have a Budget for Repairs and Maintenance of the Club's Sailing Yachts:

The motion was carried, unanimously. The Sailing Secretary and a Sub-Committee will propose and table an annual budget to the AGM and will manage the R&M of the sailing yachts.

Appointment of Auditors

There being no objections, the Committee's recommendation to appoint Messrs. Ying & Associates (No. AF002038) as the Club's auditors for 2020 was carried.

Installation of a new pontoon joint: The connection between the pontoon landing from the stairway to the lateral pontoons was recently fitted with a raised platform which maintained a gap between them. It was hoped that this gap feature could help release floating rubbish which





normally gets stuck at the closed junction of the two pontoons.

Club Fleet Sailing Program:



The Club held two fleet sailing programs on 5th July and 19th July, respectively, with the enthusiastic participation of 7 boats. The Sailing Section will next embark on the 2nd Series of the planned 3 series for the year. The next fleet sailing events are scheduled to be held on 9th August and 23rd August, respectively. Status of Seri Tenggara:

The Seri Tenggara was a gift the family of the late Mr Goh Thiam Hee made to the Club at the AGM in 2019. Repairs and restoration works began in May 2019. The hull and structural restoration will take approximately 16 months to complete. Currently, the boat is berthed at the Club pontoon for preliminary sea trials. The Seri Tenggara will serve as the Committee boat during the regatta and other water events.





Stand-in Jinggo for the Club: The Club's regular jingo has had to be pulled from service to undergo repairs to the engine and body. The Club has gotten another jingo

in the form of a 15 ft foam dinghy. The jingo is gifted by our Club contractor, Ah Meng, and is powered by a 15hp engine.
