Terms and Conditions of Term Membership (Ref: Constitutional Rule 5.1)

- (1) Term Members shall be over the age of eighteen (18) who are interested in certain of the activities and privileges offered in the Club but are not in full need to become either an Ordinary Member or a Preference Member, yet.
- (2) Term Members shall pay prior to election an annual subscription fee; this subscription must be paid upfront and will be non-refundable.
- (3) Term Membership shall be for a fixed period of twelve months and shall expire automatically at the end of the twelve months period.
- (4) The Committee shall have an absolute discretion to reject applications for extensions or renewals of Term Memberships as it thinks fit.
- (5) Term Members do not have any right to vote on any matters They have no right to propose nor to second candidates for membership and shall have no share in the property and assets of the Club.
- (6) Term Members do not have credit facilities and shall settle their transactions at the Club, including for food and beverage expenses, by cash or credit cards.
- (7) Term Members will be entitled to a discount of 20% for food and beverage expenses and any other promotional offers for other Club services like boat rentals, swimming and sailing lessons, social, sailing or fishing event participation fees which the Committee may decide from time to time.
- (8) Term Members are not entitled to Members' rates for services at the boat yard, slipway and pontoon facilities in RSYC. Term Members do not enjoy privileges as visiting members at reciprocal or affiliated clubs of RSYC.
- (9) The Committee reserves the right to take disciplinary action, including summary dismissal, against errant Term Members.

Other Terms and Conditions:

1. The Term Membership card is non-transferable.
2. A fee of RM20.00 (Ringgit Malaysia Twenty Only) shall be charged for a new card to replace a lost card.
3. The Term Membership card must be presented when making any transactions at the Club or when requested by Club or security personnel.
4. Each Term Member shall be entitled to apply for one Members' Car-parking sticker.
5. The Club restaurant reserves the right to collect a deposit or advance payment for bookings for group functions.
6. The Club reserves the right to take disciplinary action against any Term Member who breaches the rules and decorum of the Club and the T&Cs of membership including summary dismissal without refund or compensation of any fees paid.
